# Village at Legacy – Phase II – General Contracting Addendum No. 2

## **Definitions for this Addendum:**

- "Phase 1" Refers to the active construction site, as shown on sheet C201 in the bid documents for Phase 2.
- "Phase 2" Refers to the active bidding project for the Village at Legacy Phase 2.
- "Contractor" Refers to Phase 1 Contractor.
- "Bidder" Refers to active Bidding Contractor for Phase 2.
- "Ashbury Rd Expansion" or "Access Road"- Refers to the new road being built from Katie Kerr Drive, in Phase 1, to provide access to the two sites.

## 1. Katie Kerr Drive Construction Entrance Access:

a. The City of Decatur has determined that <u>no Contractor or Bidder</u> shall use the private roads that are part of Legacy Park to access Phase 1 or Phase 2 of the Village at Legacy. The Contractor and Bidder must cooperate to utilize a shared project access from Katie Kerr Drive. This access point (Ashbury Rd Extension) is being built by the Phase 1 Contractor. ### 2. Construction Road Access – Phase I Contractor and Phase II Bidder Cooperation

- a. Phase 2 Bidder must not hinder the ability of the Phase 1 Contractor to deliver the road as required in their project plans.
- b. Phase 2 Bidder must acknowledge that the construction of the Access Road will require stoppages in work in Phase 2 when the road construction is underway, up to and including, final topcoat paving, and striping.
- c. Bidder shall provide a written plan of action with their bid, demonstrating the Bidders' capability of fully cooperating with the Phase 1 Contractor to avoid adverse impacts to the completion of Phase 1 and also to avoid adverse impacts to the completion of Phase 2.
- d. Bidder will provide a written schedule to demonstrate the completion of Phase 2 recognizing this access challenge between the phases. The planned delivery of units (apartments) for Phase 2 is during February 2026 with final completion of units in March 2026.

#### 3. Phase 2 Access Road Construction Budget Responsibilities by Phase 2 Bidder

a. Bidders shall include, as part of their bid submission, a budget that would include funds for any additional repairs or road work necessitated by this Access Road requirement and provided as a line-item allowance. Bidder will be responsible for assuring the return of the Access Road to a condition acceptable to the City of Decatur at the completion of Phase 2.

Please note that the Bidders' response to the requirements above will be a major determining factor in evaluating them as a responsive and responsible bidder. Failure to address these required strategy and budget items correctly and thoroughly will result in being determined to be a non-responsive bidder.
