For example, on Attachment A, the Non-Collusive form should be Attachment H; but in the specs this is attachment H is the Certification Concerning EEO. Will these documents be re-issued?

#### Answer:

Contained in "Section 00 0004 – Instructions to Bidders Section 1.9.E." Bidders are to provide the following documents to be considered:

- **1) Bid Form** It summarizes the contract price for the Work as detailed and as described in these instructions. This also includes number of calendar days for completion and acknowledgement of addenda.
- 2) Schedule of Values/Bid Spreadsheet Submit the completed .xls document with the bid. This form needs to be completed in full. Do not modify this form with the exception of adding required categories as indicated. Provide as much break-out in each division as possible. One large budget number for each division will not be accepted. The excel file must be returned with the bid.
- **3)** Narrative of Work It should narrate the work to be completed and identify a specific list of any items NOT included in the bid. Include the requested information about the preferred subcontractors here.
- **4) Construction Schedule/Timeline** Provide a proposed schedule in GANTT format, showing how to construct this project in the timeframe identified.
- **5) Outline of Phasing** A coordinated graphic narrative with overall construction schedule for each phase.


- **6) Drawing Index** Reference list to the sheets and date of the construction documents.
- **7)** Items Included under 'General Conditions' A detailed list of items included in the "General Conditions."
- 8) Resumes Provide Superintendent and Project Manager's resumes.
